ABOUT THIS INDUSTRY SURVEY REPORT



A wide range of industries were represented among the organizations surveyed for this report.



Percentage of Users by On-Premises Email System, 2016 and 2017





Views on the Need for Third Party Offerings in Office 365 Environments







Solutions Implemented to Support the Migration to Office 365





Solutions That Have Been Implemented to Support Ongoing Use of Office 365









Plans for eDiscovery- and Legal-Related Compliance Archiving and Backup in Office 365





Approach That Would be Taken for Migrating to Exchange Online or Office 365





for Archiving






